 Health has been tasked to work on the food trucks. Substation design is in progress. Document
 everything. Call 911, call non-emergency, use 311, use the 311SA app.
- Neighbor Feedback: Can food truck closing times be addressed? Is there a law loitering in front
 of houses? If they are on your property, yes, if they are on the street no. Residential parking
 program in the works; standards for businesses should be held to a different standard when
 they are up against a residential zone. Where is the line as far as trespassing and the SAPD
 action?
